Event Release and Code of Conduct

BY REGISTERING FOR AND ATTENDING WEBEXONE (THE "EVENT"), I, FOR MYSELF, MY HEIRS, PERSONAL REPRESENTATIVES, EXECUTORS AND ASSIGNS, HEREBY AGREE TO RELEASE, WAIVE, FOREVER DISCHARGE AND COVENANT NOT TO SUE CISCO SYSTEMS, INC., ITS OFFICERS, DIRECTORS, SHAREHOLDERS, EMPLOYEES, VENDORS, AGENTS, AND CONTRACTORS (HEREINAFTER "CISCO") AND WILL DEFEND, INDEMNIFY AND HOLD CISCO HARMLESS FROM ANY AND ALL ALLEGED AND/OR ACTUAL LIABILITY, CLAIMS, ACTIONS, LAWSUITS, DAMAGES, OR LOSSES, OF ANY KIND ("CLAIMS"), INCLUDING ATTORNEY'S FEES, WHICH ARISE OUT OF OR RESULT FROM MY ATTENDANCE AT AND PARTICIPATION IN THE EVENT AND ANCILIARY ACTIVITIES, INCLUDING BUT NOT LIMITED TO, IF APPLICABLE, PERSONAL INJURIES, ACCIDENTS OR ILLNESS (INCLUDING DEATH) AND PROPERTY LOSS OR DAMAGE WHETHER OR NOT FORESEEABLE.

I have read and understand the previous paragraph. I know, understand, and appreciate these and other risks that may be inherent in attending the Event. I hereby assert that my participation in the Event is voluntary and that I knowingly assume all risks of injury, illness, death or other loss that may arise from or related to my participation in the Event.

SEVERABILITY: I further expressly agree that the foregoing waiver and assumption of risk agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
